# **Executive Summary**

On May 15, 2018 bids were opened for Contract SD-2018-09. The project includes repairs, rehabilitation, and improvements of stormwater drainage systems at various site locations throughout the City of Durham. The City solicited bids for this project through the Small Local Business Enterprise (SLBE) program. The lowest responsive bid was submitted by White Oak Construction Corporation of N.C., of New Hill, North Carolina. The Public Works Department recommends that the City Council authorize the City Manager to execute a contract with White Oak Construction Corporation of N.C., for Contract SD-2018-09 in the amount of \$352,895.00.

### Recommendation

To authorize the City Manager to execute Contract SD-2018-09, Drainage Structure Access and Stabilization, with White Oak Construction Corporation of N.C. in the amount of \$352,895.00;

To establish a contingency fund in the amount of \$52,934.25; and

To authorize the City Manager to negotiate change orders for Contract SD-2018-09 provided that the total project cost does not exceed \$405,829.25.

# Background

The project involves the furnishing of all materials, labor, equipment, tools, etc. unless otherwise specified, for the complete installation of repairs, rehabilitation, and improvements of stormwater drainage systems at various site locations throughout the City of Durham. The City solicited bids for this project through the SLBE program. Twelve sites will be addressed as part of this work. The sites are located in City rights-of-way and on City-owned property.

#### **Issues and Analysis**

The initial apparent low bidder, Vortex Drainage Systems, LLC, was deemed to have submitted an unresponsive bid that was rejected. The rejection was based on a failure to submit evidence of a Good Faith Effort in seeking to meet the City's Underutilized Business Enterprise (UBE) goals for the project. As a result, the bid is not compliant with the Ordinance to Promote Equal Business Opportunities in City Contracting. The next lowest bidder, White Oak Construction Corporation of N.C. was deemed to be responsive.

The following is a summary of bids received:

The Public Works Department recommends awarding Contract SD-2018-09 to White Oak Construction Corporation of N.C. in the amount of \$352,895.00.

#### Alternatives

The Public Works Department has not identified any alternatives since the bids received are competitive and are consistent with the opinion of probable cost prepared by staff.

#### **Financial Impact**

This project is budgeted for in the adopted Capital Improvements Project Ordinance (#15133) for storm drainage repairs in the following accounts.
