Subject: Contract ST-302, Street Repairs and Repaving Project 2020

Executive Summary

On October 25, 2019, the Department of Public Works opened bids for Contract ST-302 Street Repairs and Repaving 2020. The contract involves milling, patching, utility adjustments, asphalt paving, and pavement markings at various locations in the City of Durham (Attachment A - Vicinity Map). The lowest responsive bid was submitted by FSC II, LLC dba Fred Smith Company of Raleigh, North Carolina.

Recommendation

The Administration recommends that the City Council authorize the City Manager to execute a contract for ST-302, Street Repairs and Repaving 2020 with FSC II, LLC dba Fred Smith Company in the amount of \$4,297,944.50; establish a contingency fund in the amount of \$644,691.68; and authorize the City Manager to negotiate and execute change orders to the contract provided that the total contract cost does not exceed \$4,942,636.18.

Background

The Department of Public Works continues to be committed toward a balanced asphalt pavement maintenance program. A critical component of that is to perform the right treatment to the right road at the right time. The 2019 paving effort worked well by focusing on two areas of treatment: repaving and the preservation treatments. Public Works will continue to split these two different types of paving work into separate projects to keep cost down and increase the quality of work. ST-302 is the repaving portion of the 2020 asphalt maintenance program.

The ST-302, Street Repairs and Repaving 2020 project provides for the milling, patching, utility adjustments, asphalt repaving, and pavement marking, of various locations throughout the City of Durham for a total of 19 Iane miles. The locations are spread across four PAC Districts, will include three neighborhoods, and will repave several arterial streets.

Additional lane miles will receive pavement preservation treatments in 2020 under project ST-303 Pavement Preservation 2020.

Issues/Analysis
