

a condition in which all individuals and communities have the information technology capacity needed for **full participation** in our society, democracy and economy.


Digital Equity is **necessary for** civic and cultural participation, employment, lifelong learning, and access to essential services.

"Even during normal teaching conditions, students without high-speed Internet access at home have lower grades, lower digital skills and are less likely to plan to attend a college or university."



#### I. Expand Broadband access and adoption

- Increase the areas that have Broadband connectivity
- Increase adoption of Broadband through outreach
- Advocate for policies that will increase Broadband infrastructure, access, and adoption

II. Increase the number of people who have a **device** that allows them to participate fully online

- Increase the community's opportunity for free or low-cost devices
- Expand device ownership in the community
- Provide support for computer devices

III. Increase **digital knowledge and skills** among all groups in the community to encourage lifelong learning

- Increase access to digital learning opportunities
- Provide ongoing support and infrastructure for digital learning
- Develop an adaptive framework for digital skills and literacy continuum


